Anti Ragging Committee- Action Plan (2022-23)

1. As per UGC regulations on curbing the menace of ragging in higher educational institutions-2009, an Anti-Ragging Committee, Anti Ragging Squad and Anti Ragging Mentoring Cell are to be constituted to prohibit ragging activities inside the campus.
2. Steps are to be taken for issuing the proceeding of the Principal on this matter.
3. Upload the details in the website of the college.
4. Confirm that the brochure of admission contains the regulations and helpline numbers.
5. Public declaration that ragging is totally prohibited in the campus before the admission starts.
6. Affidavit by student and parent are to be collected and filed during admission 2022-2023.
7. Additional affidavit is to be collected for those who seek admission in the hostel.
8. Steps are to be taken by the Head of the institution to convene a meeting (faculty members, parents, student representatives, hostel wardens etc) before the commencement of an academic session and explained the various measures to be taken to prevent ragging.
9. Posters and notices were displayed in the campus to make awareness about regulations and punishments.
10. Instructions are to be issued by the institution to have a close watch at vulnerable places and tighten the security.
11. An orientation programme by police officer for both seniors and freshers is to be conducted.
12. Printed leaflet (which includes the regulations, helpline numbers, anti ragging squad members details) are to be provided for freshers.
13. Guidelines to be provided to Committees (course in charges, student advisor, wardens, senior representatives) to promote healthy relationships.
14. Each batch of freshers are to be divided into small groups coordinated by faculty members to discuss the problems.
15. Authenticate that separate blocks in hostels for freshers and round the clock vigil in hostel premises is provided.


