The Company is at present engaged in the manufacture of Indian Made Foreign Liquor(IMFL) only and the products are sold through Kerala State Beverages Corporation Ltd. KSBC a Company wholly owned by Government of Kerala, which is a monopoly procurement Agency of IMFL.
